# ELIGIBILITY REQUIREMENTS

#### Age Eligibility

- Infants and toddlers (Early Head Start) Birth to 3 years old
- Preschoolers (Head Start) 3 or 4 years old by 9/1

### <u>Eligibility</u>

Children from low-income families are eligible for participation if their families' incomes are below the federal poverty line (see Federal Income Guidelines below), or if their families are receiving Public Assistance from TANF (CalWorks), Supplemental Security Income (SSI), Foster Care, or if they are homeless.

#### **2016 Federal Income Guidelines**

For family units with more than 8 members, add \$4,160 for each additional member

#### Enrollment Documents – The following documents will be required ONLY if you are offered a spot:

- 1. *Proof of Eligibility* ➤ One month's worth of current (within 30 days) pay stubs, employment verification from current employer, or self-declaration of income
  - > Unemployment Benefits, disability income or worker's compensation
  - > Notice of Action for CalWorks or Statement of Receipt of SSI or Verification of Foster Care
  - College/university scholarships, grants, fellowships, and assistantships
  - Documentation of homelessness, including a letter from a social worker, contract with a shelter or other documentation of unstable housing
- 2. *Proof of Age* Birth Certificate, Foster Placement or other document that shows a relationship between parent and child for every child in the home that is under 18 years of age
- **3.** *Proof of Single Parent Status* Records of Divorce/legal separation, Custody documents, Rental/Lease Agreement, parent licenses/I.D. showing different addresses, Absent Parent form, If renting a room a bill with the address and a letter from the person renting you the room
- 4. *Proof of Residency (Required for Berkeley, Albany and Emeryville Residents)* Utility bills or Bank Statement or Driver's License or Rental Agreement
- 5. Child's Immunization Record
- 6. Other
  - Proof of Pregnancy from Doctor for Pregnant Women
  - Cal-SAFE letter for student parents
  - > Proof of diagnosed disability Current IEP/IFSP if applicable
  - 9600A Form
  - Consent Form
  - > Proof of student status Student ID, class schedule, etc.

# **Full-Day Services**

Enrollment in full-day services is also available. In order to qualify for full-day services, a family must demonstrate a need for child care by either working or attending school/training, or having a diagnosed disability. Verification of need, family size and income must be provided. The agency will then determine your eligibility for full-day services.
