## **Summer Food** Program

## Purpose / Propósito:

The Summer Food Program provides children with free nutritious meals and snacks they need to learn, play, and grow, throughout the summer months when they are out of school. Meal sites are located at schools and community centers near you.

- No registration or verification is needed.

- Low income.
- Bajos recursos.

# Women, Infants and Children (WIC)

## **Purpose**

The Women, Infants and Children (*WIC*) Program is a nutrition program that offers nutrition advice, help with breastfeeding and healthy food for pregnant and breastfeeding women, infants and children under the age of 5. Participants can receive \$50 to \$100 per person each month in checks

## Who is Eligible?

Low income pregnant, postpartum, and breastfeeding women

for healthy food, such as fresh fruits and vegetables as well as healthy grains.

• Low income children under 5 years of age

### What Verification is Needed?

- Identification
- Proof of address
- Proof of income

## **Head Start**

## **Purpose**

Head Start is an early childhood development program that participates in the USDA Child and Adult Care Food Program. This allows Head Start-enrolled children to receive a free breakfast, lunch and snack during the day.

## Who is Eligible?

The following qualifies a child for Head Start:

- Children under five years old from low income families;
- Children under five years old with special needs;
- Fostered child, homeless child, or family receiving public assistance;
- Residency in the service area;

### What Verification is Needed?

- Proof of birth (birth certificate, baptismal record, etc.);
- Proof of annual income (1040 tax form, CalWORKS printout, SSI statement, employment check stubs, letter from employer, etc.);
- Proof of residency/homelessness;
- Immunization records

## School Meals

## **Purpose**

The School Meals Program provides nutritious well-balanced meals (breakfast, lunch, snack and *supper*) to children enrolled in K – 12 schools during the school day. The program provides free, reduced price, or paid meals to students based on eligibility information.

## Who is Eligible?

The following automatically qualify for no cost meals:

- Homeless students
- Students receiving CalFresh, FDPIR, CALWorks or KinGap
- Foster children

Students enrolled in migrant education programs

The following may qualify for free/reduced cost meals based on the scale below:


## Where Can I Pick Up Application Packets?

## CalFresh

## **Purpose**

CalFresh, formerly known as Food Stamps, can help provide money for nutritious foods for your family. CalFresh is accepted at most farmers' markets and grocery stores. The program uses an easy credit card format called Electronic Benefit Transfer (*EBT*).

## Who is Eligible?

- US citizens (Except persons receiving SSI/SSP benefits)
- Most immigrants Legal Permanent Residents

## What Verification is Needed?

- Identification
- Social Security Number
- Proof of Income (for one month)
- Proof of expenses rent, utility bills, childcare, etc.
- Proof of medical expenses (if over 60 years old)

## What Resources/Income Can I Have?

• Income depends on the number of people in the household.

## **Emergency Food Services**

## **Purpose**

The Alameda County Community Food Bank operates a toll-free Food Helpline that connects callers to emergency food providers in their neighborhoods for same-day free hot meals or bags of food (1-800-870-3663). The Food Bank also offers referrals and application assistance toward food programs, such as CalFresh, School Meals, and WIC (*Women, Infants and Children*).

## Who is Eligible?

- Alameda County residents
- Families and individuals who need help with emergency food

### What Verification is Needed?

• One form of ID for every household member (i.e., driver's license, library card, MediCal card, school ID, etc.)

## What Resources/Income Can I Have?

• Low income and few or no resources

## What Happens When I Call the Helpline?

When you call the Food Helpline, press the option for "Food Today". You will then speak to an operator who will ask you a few questions. Based on your zip code, that operator will search for locations in your neighborhood that are distributing food bags or serving hot meals. The operator will then let you know where to go for help with emergency food that same day. If you are calling for help in applying for other food programs like CalFresh, let the operator know or press the option for "CalFresh" at the beginning.
